Ski Trip USA 2019 **Saturday 6 April – Sunday 14 April 2019**

The ski trip for 2019 will be to the resort of Killington, USA. Killington offers a wide variety of pistes providing excellent skiing for all abilities, from the beginner to the more experienced skier. In addition to the skiing activities, there will be a full programme of evening entertainment. We will also have a stopover in New York where we will visit a range of iconic landmarks.

The cost of the trip is likely to be in the region of £1,565.00* including transport, half board accommodation, five days' ski lessons, equipment hire, a ski lift pass, comprehensive insurance and evening entertainment.

I undertake to pay £1,565.00 to Oxted School, which my child attends/will be attending as from September 2018 as follows:

- A non-refundable deposit of: £400.00 by return
- £400.00 by 4 May 2018
- £400.00 by 6 July 2018
- £365.00 by 19 October 2018

I agree that if I shall fail to pay the sums mentioned above on or before the due dates or if before **January 2019** my child ceases to be a registered student at Oxted School, then Oxted School shall be entitled at their discretion to arrange for the place reserved for my child to be taken by another child, but if the place is not so taken I shall remain liable to pay Oxted School the sums due in accordance with my undertaking. Provided the place is so taken, Oxted School shall refund to me any sums paid by me to them.

I acknowledge that Oxted School, notwithstanding any approval by them of this application, shall be entitled to cancel the visit at any time in which case they shall be liable to refund to me any sums paid by me to them and still held by them as agents for me but they shall not be liable to refund to me any expense which I may otherwise incur, and without prejudice to the generality of the foregoing Oxted School shall in particular not be liable to refund to me any sum which has been paid by them on my behalf to the tour operator/other suitable description, unless such money has been or is at any time thereafter refunded to Oxted School.

I acknowledge that Oxted School:

- (i) may at any time alter the venue, route or mode of transport owing to unforeseen circumstances.
- (ii) may exclude from the visit any child whose conduct or demeanour between the date of this undertaking and the commencement of the visit is unsatisfactory to such a degree that his/her presence might have a disruptive effect on general discipline during the visit, which shall be a matter for Oxted School in their absolute discretion to determine, and in such an event, the deposit paid in respect of the child shall be forfeited.

In the event of the cost of the said USA 2019 visit being increased, Oxted School shall be entitled to increase the sum specified in Paragraph 1 hereof to take account of any such increase of cost as aforesaid.
